## DOH reiterates importance of airflow and vaccination as protective measures against airborne COVID-19

Clarifications on the spread of COVID-19 both through airborne particles and droplets were made by Health Undersecretary Maria Rosario Singh-Vergeire in the latest press briefing with Cabinet Secretary Karlo Nograles, today, 28 January 2022.

Reminding the public that COVID can easily spread through the air, Undersecretary Vergeire stated that, "Kinakailangan nating sumunod sa minimum public health standards gaya ng pagsusuot ng face masks at physical distancing - hindi lamang ng ating mga sarili kundi pati ng mga taong nakapaligid sa atin."

Implementation of minimum public health standards (MPHS) and the "mask-hugas-iwas-airflow" has been in place to remind Filipinos of the different health protocols. In line with that, Undersecretary Vergeire underscored that ensuring proper ventilation in homes, workplaces, and other establishments is highly-recommended to allow the circulation of clean air indoors, which helps further prevent the spread of the virus.

The DOH noted that proper ventilation can be achieved by always keeping windows or doors open for fresh air to flow or putting an electric fan in front of a window for good air circulation. If the weather's too hot to keep windows open, one can open it for a few minutes every hour.

Vergeire also reminded the public that in case they're meeting with friends, colleagues, or relatives, they should make sure the meeting is in a well-ventilated space. It is best to practice social distancing and the wearing of face masks at all times. If possible, limit interaction to an hour to limit transmissions and infections.

With the ongoing expansion of vaccination coverage and opening of more sites through programs such the Department's "Resbakuna sa Botika at Medical Clinics" program, the Undersecretary noted the importance of vaccines as our protection from COVID-19, "Hinihikayat ang lahat na upang maging protektado, tayo ay maging bakunado. Magparehistro at agarang tumungo sa ating mga vaccination sites at makipag-ugnayan na sa ating mga LGUs para makapagpabakuna laban sa COVID-19."

Preparations are also underway for the rollout of pediatric vaccinations for children aged five (5) to eleven (11) years-old this coming February. As children are also susceptible to the virus, and cases around the country remain high due to the Omicron variant, it is imperative that younger populations have access to the safe and effective vaccines.

The DOH urges the public to strictly follow all of the minimum public health standards and protocols implemented by the Department. In addition to vaccination, these practices will help in achieving maximum protection from the virus. These collective efforts in preventing further transmission of COVID-19 is a step towards living in the 'new normal'. (DOH)

## Every Christian is a 'fisher of men'

The gospel of this 5th Sunday relates about Jesus calling his first apostles — a band of simple fishermen. The Lord must have made a deep impression on them that "they left everything" — their work, their boats, their families — and followed him (Lk 5:11). This band formed the core group on which Christ founded his Church

Unfortunately, many have the idea that the call of Christ is addressed only to the apostles and their successors — priests, bishops and popes.

That's not true. Every Christian is commissioned to the ministry of healing, preaching and teaching by virtue of his or her baptism.

The Decree on the Laity of Vatican II states: "Incorporated into Christ's Mystical Body through baptism and strengthened by the power

of the Holy Spirit through confirmation, the LAITY are assigned to the apostolate by the Lord Himself' (3).

How can you be an apostle of Christ or "fisher of men"? Aside from attending Holy mass and receiving the sacraments, you could participate in church works in your parish. Today there are numerous lay Catholics who sacrifice time, talent and treasure for the church, rendering services as lay ministers, lectors, collectors, choir members, catechists, social workers.

Then there are those involved in church organizations like the Legion of Mary, Knights of Columbus, Catholic Women's League as well as the renewal movements like the Marriage Encounter, Couples for Christ, El Shaddai, Loved Flock, Lord's

Before I start my piece, I would like to tell you this: The names used in this essay are fictitious. However, to the yayas (and yayos) in my life, you know who you are.

"Jet, kakain na (Jet, time to eat)," my aunt and uncle's widowed, then-60-something former yaya/kasambahay (nanny) Leni beckoned at me from our old duplex home. In her usual poker-faced manner, she invited me to eat with my cousins Larry, Maharlika, and Dante, together with their parents Bongbong and Sara.

Coming from the other house, newly-built, where I just had my shower, I told her upon facing her, "Opo, Manang (Yes, Manang)!"

Because I was having hunger pangs, I proceeded to the table, where I had my dinner with my cousins. It was another of those rare nights without my (now-deceased) grandmother, who as usual was playing mahjong with her geriatric super friends, one of them a well-revered school executive and another a practicing psychologist.

On another occasion, I was over the phone with

our family nanny Yaya Leila. Hearing about the burns that I got from leaning against a motorcycle muffler, she was aghast and at the same time disappointed in me for not being careful.

"Kumusta na ang mga paso mo (How are your burns)," she asked me. Reassuring her that I would be fine, I quipped, "Ayos lang. Kaya naman ng powers ko, parang si Hesus sa krus (They're about to heal. I can withstand the pain, just like Jesus nailed on the cross)!" Though she nagged me about the possibility of having a small scar on my right leg, I decided to cheer up despite her "prediction" (the scars have faded over time, thank God).

It's so heartwarming to be called, remembered, and reminded by our yaya or yayo (we call them kasambahay to be politically correct and inclusive), isn't it? Being with us 24 hours a day, six or seven days a week, we would feel elated, albeit at times a little annoyed, by our yayas' constant reminders and occasional pieces of advice.

For some of us who are the English-speaking, upper-middle-class or elite type, we would respond with, "yeah, yeah, yaya (or yayo)". On the other hand, for some of us who belong to the middle class and are the bilingual, "Oo na (Yeah), yaya" would be our reply to them.

either frown at our yayas (or yayos) or throw things at them out of tantrum, whether we admit it or not.

From our infant (or toddler) years to even adulthood, our yayas (or yayos) have been significant parts of our lives. Some of them come and go like the weather; some stay for so long that even their quirks are known to us. Married, single, widowed, or separated, they act as surrogate parents to us whenever our parents would be out making both ends meet and going to the extent of sacrificing their own happiness. They, too, give up their personal happiness just to serve us. From sunrise to sunset, they cut back on their sleeping hours just to run the house. In collaboration with our parents, they guard us and our home with their lives, notwithstanding their fear of being scrutinized by their employers even for just the slightest mistakes. We need to encourage them to save not just for emergencies but for businesses and for their retirement.

Our yayas/yayos should not be looked down on by us. We've got to consider them part of the labor force because of the professionalism and the dedication they possess.

Yeah, yaya/yayo, you're a wondrous wizard not only at home but also in dispensing life lessons that remain in our hearts and minds!

## 84% of Ilocos Sur's target population are now fully vaccinated

VIGAN CITY, Feb. 4 (PIA) – Some 488,806 individuals or eligible 84.35% of the target population of the province of Ilocos Sur are now fully vaccinated against Covid-19 as of February 3, according to the Department of Health-Ilocos Center for Health Development (DOH-CHD1).

The province has a total of 724,395 estimated population and more than 500,000 of this have received at least one dose of Covid-19 vaccine.

There are some 158, 758 remaining residents of the province's eligible population who haven't received a single dose of Covid-19 vaccine as per the DOH.

Dr. Rheuel C. Bobis, Medical Officer IV of the DOH CHD1, said the part 3 of the National Covid-19 Vaccination Days will be held on Sur)

February 10 and 11, 2022 to vaccinate all 12 years of and above prioritizing the administration of booster doses and primary and booster doses of A2 and A5 population.

Meanwhile, Ilocos Sur now has listed 11 Covid-19 Omicron variant cases as of January 31.

Nine of these are local residents while two are returning overseas Filipinos, Dr. Bobis said during the 26th episode of the PIA and DOH in Ilocos' Virtual Presser on Friday.

The province has recorded a total of 20, 018 Covid-19 cases since March 2020.

Of which 1, 646 are active cases while 18, 129 cases have recovered as of Thursday.

## Bello pours DOLE aid in Ilocos Sur

Labor Secretary Silvestre "Bebot" Bello III has brought aid to hundreds of Ilocano, as he visited the heritage province of Ilocos Sur on January 31-February 1, 2022 to lead in the awarding of various projects to beneficiaries of the Department of Labor and Employment.

Bello, Sec. who traces his roots in the town of Santa in this province, was warmly welcomed by his fellow Ilocanos who excitedly livelihood received and employment aid through DOLE Integrated Livelihood and Emergency Employment Program (DILEEP) and the Tulong Panghanapbuhay sa Ating Displaced at Disadvantaged Workers (TUPAD).

In Narvacan, around 300 marginalized workers received free bikes with a package of mobile phone with P5,000 load. Called the FreeBis, this DILEEP component is geared towards jumpstarting livelihood of low-income workers who can use the

bikes in various trades such as vending and service delivery in their barangays.

In Santa, members of the Association of Barangay Rural Enterprise Workers Santa (ABREWS) received assistance from DOLE, as the Labor Secretary handed in checks for various projects.

The DOLE funded the association's Bagoong Ipon Processing Project, with P1,000,000 to benefit 60 members; and another P1,560,000 for Sari-Sari Store Project to cover 52 beneficiaries.

FreeBis worth P1,040,000 were also given to 52 ABREW members. Meanwhile, 935 TUPAD workers also received their wages worth P4,420 after rendering 13 days of community work.

Bello underscored to the beneficiaries that these support interventions are a manifestation of the government's unwavering commitment to bring social development in

## SSS La Union puts up call center to answer members' queries

CITY, Jan. 31 (PIA) The Social Security System (SSS) La Union has put up a call center booth as an additional platform to communicate with their members and aid their queries and concerns.

Christian Andrew Rillorta, SSS Regional Communications Officer, said initiative is in view of the continuing threats of coronavirus disease 2019 (COVID-19).

"Members, instead of physically queueing in the branch for inquiry, may call the branch's call center and they will be assisted by an employee," Rillorta said.

On the average, the SSS La Union branch receives 45 calls daily, mostly for verification follow-ups submitted claims.

Rillorta said all calls received and assisted are

SAN FERNANDO recorded in a log sheet as the basis for status verification.

> Further, the branch is implementing the number coding scheme where members and employers are allowed for their transaction based the 10th digit of their Social Security Number/ Common Reference Number (CRN) Employee ID Number.

Those ending in 1 and 2 are to transact only every Monday, 3 and 4 every Tuesday, 5 and 6 every Wednesday, 7 and 8 on Thursdays and 9 and 0 on Fridays.

## Multiple DPWH projects in Ilocos Sur, in the works

VIGAN CITY, Jan. 31 (PIA) -- The Department of Public Works and Highways (DPWH) in Ilocos Sur will continue to lead the construction of multiple infrastructure projects for 2022.

According to District Engineer Emil Rodriguez Ganaden of the Second District of Ilocos Sur, there are still bridges which have not yet widened in the second district of the province such as bridges in Santa Maria and Narvacan towns.

"Our focus is to make the roads, four lanes and also our flood control projects to protect lives," Ganaden said.

These projects include Poblacion Norte Bridge, Sulvec Bridge in Narvacan and the flood control projects in San Antonio River worth P90 million pesos, among others.

Ganaden said: "Our

fund in 2022 is much bigger than our funds from 2020 and 2021. This year, it is P2.3 billion, aside from the projects implemented by the regional office, our fund is big, so we have a lot of projects, we have 122 projects."

However, Ganaden said while the budget for capital outlay increased, the fund for routine maintenance decreased to P20 million that is why DPWH checks the situation on the roads because the limited funds has caused the agency to cut back on hiring personnel.

# Imee: Release poll precinct numbers early for less delays, fewer disenfranchised voters

Senator Imee Marcos expressed worry that mock polls held last year did not thoroughly run through pandemic protocols and may lead to voters losing their way at election centers and being disenfranchised in the May 9 elections.

Marcos, who chairs the Senate committee on electoral reforms and participation, people's said that overcrowding took place during last year's mock polls due to technical and logistical glitches.

**Participants** spent much time looking for their names and assigned precincts, vote-counting machines jammed rejected ballots, and a weak internet signal delayed the voting process.

Marcos questioned the Comelec on the role of the Department of Health (DOH) in implementing health protocols in polling precincts nationwide, after the Comelec reported that it took 10 minutes and 47 seconds for each voter to cast a vote during the mock polls.

"What exactly is the role of DOH? With the overcrowding that took place, did we not fall short applying Covid-19 protocols?" Marcos asked.

Marcos recommended that another round of mock polls be held with more participation from DOH personnel and for the Comelec to immediately release guidelines on how election campaigns should be conducted.

"I urge the Comelec to issue guidelines ASAP on how to maintain safety during caravans, sorties, house-to-house and town hall meetings," Marcos emphasized.

The Comelec should also speed up the release of voter precinct assignments through social platforms instead of just mailing the information to registered voters, the senator added.

Marcos expressed regret that early voting for vulnerable groups could not take place on May 9 because the Senate did not pass Senate Bill 1104, which she authored.

The bill could have allowed vulnerable groups like senior citizens, persons with disability (PWDs), and pregnant women to vote ahead of the general public.

The privilege could also have been extended to health workers, poll watchers, military and police personnel, and the media, the senator said.


